 - **A biographical statement. Include: goals, educational background, employment history, extra curricular activities both in and out of school (include the purpose or goals and your role in any club or organization that you are a member). Include any other pertinent information about yourself.**
4. **Please provide the following statements &/or copies:**
 - **Your current GPA (school transcript)**
 - **If employed, the average number of hours worked per week (statement from employer)**
 - **FAFSA score (statement or student aid report received after filing for financial aid at www.fafsa.ed.gov)**
