

# Financial Aid Checklist

## FAFSA ([www.studentaid.gov](http://www.studentaid.gov))

- Complete the Free Application for Federal Student Aid (FAFSA).

- Use the IRS Data Retrieval Tool to report tax return information.

## FSA ID ([www.studentaid.gov](http://www.studentaid.gov) or [mystudentaid mobile app](#))

- Ensure you (and your parent, if applicable) have created your Federal Student Aid ID. This gives you access to all Federal Student Aid's online systems.

## ADMISSIONS ([www.coastalcarolina.edu/admissions](http://www.coastalcarolina.edu/admissions))

- Submit an Admission Application. Admission applications may be submitted to the college in person, by mail, or via the college website. Applications are also available through the website for the College Foundation of North Carolina at [www.CFNC.org](http://www.CFNC.org).
- Complete placement through one of the approved methods.
- Meet with an academic counselor. No appointment needed.

## VERIFICATION, if applicable

- If selected for verification, you will receive an email and a letter from the Financial Aid Department asking to complete verification.
- Submit the required documents, in a timely manner, to the Financial Aid Department to complete verification.

## FINANCIAL AID AWARD INFORMATION

- Log into your *MyCCCC* Portal, click "Web Advisor", click "Financial Aid"
- Printout award letter, sign, and return to the Financial Aid Office.
- Attendance Verification
- Access your *MyCCCC* portal at [www.coastalcarolina.edu](http://www.coastalcarolina.edu). Next, click on Softdocs Etrieve, click Forms, click STI-Pell Grant Verification, click in the section box to select the class you are verifying attendance. Select "Yes" or "No" if you are receiving the Pell Grant this semester, read the consent statement, click in the box indicating your consent, click on submit, and the form will be transmitted electronically to the Financial Aid Department. If you do not see the submit button, then you are trying to submit it too soon. Hard copies will not be accepted; it must be submitted electronically.

## REFUNDS

Go to [www.coastalcarolina.edu](http://www.coastalcarolina.edu), select "MyCCCC" at the top right of the page, log into your account, and select "Bank Mobile."

- Follow the prompts to set up your account to receive refunds from Coastal.
