All You Need to Know for the

Spring 2024 Cosmetology Program

At-A-Glance



Coastal Carolina Community College's Cosmetology Diploma Program is a full-time, day-time Limited Enrollment Program. The Cosmetology Program is a 16-month program that includes 1,500 training hours required by the North Carolina Board of Cosmetology.

Prior to meeting with an Academic Advisor/Counselor:

- Complete a residency application through the NC Residency Determination Service (RDS). RDS can be completed at https://ncresidency.cfnc.org.
- Complete an Admissions Application to Coastal Carolina Community College. Applications can be found online at https://www.coastalcarolina.edu/admissions/admissions-steps/new-student/.
- Submit official high school/high school equivalency transcript as well as official transcripts from all postsecondary institutions attended. Official transcripts may be sent to etranscripts@coastalcarolina.edu.

Eligibility Application Information:

- Eligibility Applications will be available beginning Monday, September 18, 2023.
- Eligibility Applications must be completed with an Academic Advisor/Counselor.

Cosmetology Diploma Program Acceptance Process:

- There are 20 seats available for the Spring 2024 program; eligible applicants who have completed
 applications will be accepted on a first-come, first-served basis. All other eligible applicants will be
 placed on an alternate list (Note: An eligible applicant has a current application and all official transcripts
 received).
- All applicants will receive an Agreement Form by no later than October 6, 2023 indicating if they are accepted or an alternate.
- Accepted and alternate students are required to return the Agreement Form no later than 5:00 p.m. on Friday, October 20, 2023.
- Failure to return the Agreement Form will result in forfeiture of a seat in the Cosmetology Program.
- It is the applicant's responsibility to notify the Academic Counselor, Nicole Loya, of an address and/or phone number change.
- Applications for the Spring 2024 program will be accepted through Friday, November 10, 2023.

Orientation Information:

- Accepted students are required to attend ONE orientation session.
- Sessions will be held on the following days and times:
 - o Tuesday, November 14, 2023, at 10:00 a.m.
 - o Thursday, November 16, 2023, at 5:00 p.m.
- Sessions will be located at Coastal Carolina Community College in the Multipurpose Building, Room M106.

Please keep in mind the following information:

- In accordance with the North Carolina State Board of Cosmetic Art Examiners, students must provide the following prior to the first day of class:
 - 1. Social Security card, tax ID card, or student visa information; and
 - 2. Current government-issued ID and proof of date of birth.

Students will not be permitted to begin training unless proof of identification has been provided prior to the first day of class.

- If accepted into the program, tuition must be paid and a cosmetology kit purchased before the beginning of the semester.
- Uniforms are required (plain black scrubs, black shoes, and name tag).
- Candidates admitted to the Cosmetology Program must wear their clean uniforms, name tags, and black shoes every class meeting, beginning the first class meeting.

Cosmetology Curriculum (D55140):

The Cosmetology curriculum is designed to provide competency-based knowledge, scientific/artistic principles, and hands-on fundamentals associated with the cosmetology industry. The curriculum provides a simulated salon environment which enables students to develop manipulative skills.

Coursework includes instruction in all phases of professional imaging, hair design, chemical processes, skin care, nail care, multi-cultural practices, business/computer principles, product knowledge, and other selected topics.

Graduates should qualify to sit for the State Board of Cosmetic Arts examination. Upon successfully passing the State Board exam, graduates will be issued a license. Employment is available in beauty salons and related businesses.

- Attendance at one of the scheduled orientation dates is required.
- Course substitution(s) must be made by the appropriate Division Chair.
- Completion of the program does not guarantee licensure; students must take and successfully pass the state licensure exam provided by the North Carolina State Board of Cosmetic Art Examiners.
- Students must maintain a "C" average in all Cosmetology classes to advance in the program.
- There is no guaranteed entrance into the program for any applicant.
- A computer and internet accessibility is required for the online portion of COS 111 Cosmetology Concepts I.
