## A **2022 IRS Tax Return Transcript** may be obtained through:

- Get Transcript by Mail Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript by Mail." Make sure to request the "Return Transcript" and **NOT** the "Account Transcript." The transcript is generally received within 10 business days from the IRS's receipt of the online request.
- Get Transcript Online Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript Online." Make sure to request the "Return Transcript" and **NOT** the "Account Transcript." To use the Get Transcript Online tool, the user must have (1) access to a valid email address, (2) a text-enabled mobile phone (pay-as-you-go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript displays online upon successful completion of the IRS's two-step authentication.
- Automated Telephone Request 1-800-908-9946. Transcript is generally received within 10 business days from the IRS's receipt of the telephone request.
- Paper Request Form IRS Form 4506T-EZ or IRS Form 4506-T. The transcript is generally received within 10 business days from the IRS's receipt of the paper request form.

## Acceptable Alternative Documentation

- IRS Form 1040 (pages 1 and 2); or IRS Form 1040-NR (pages 1 and 2); or IRS Form 1040-SR (pages 1, 2, and 3) and Schedule 1, Schedule 2, and Schedule 3, if applicable
  - Taxpayer signature or tax preparer information is required on the copy of the IRS Form 1040
    - Only 1 signature required if joint return was filed and
    - If completed by a tax preparer/professional the copy must include:
      - The last 4 digits of the tax preparer's Social Security Number (SSN), or
      - Employer Identification Number (EIN), or
      - Preparer Tax Identification Number (PTIN), and
      - Has been signed, stamped, typed, or printed with the name and address of the preparer
        - o Tax return simply stamped "H&R Block", for example, is not acceptable
        - Must contain above information necessary to identify the person who actually prepared the return
